UPDATED CANCELLATION AND REFUNDS POLICY

All new bookings including Groups, from October 7, 2024, forward, are subject to the following payment and cancellation terms:

• 25% deposit required within 72 hours of booking to confirm a reservation

Deposited reservations that are canceled will be subject to the following charges:

- Within 15 days of deposit: No fee*
- 365 days or more prior to departure date:* \$250 Administrative Fee per person, can be applied to a future booking within 12 months of cancellation date
- 364 to 211 days prior to departure date: 10% of full fare, per person, can be applied to a future booking within 12 months of cancellation
- 210 to 91 days prior to departure date: 25% of full fare, per person
- 90 days or less prior to departure date: 100% of full fare, per person
